- I. Call to Order—Kindred called the meeting to order at 3:31pm.

She hopes to start the task force in January 2022. Members of the CAC requested that some of the task force meetings be in person.

- SRA Replacement, Humanities. Mary-Elizabeth Murphy (Arts) has resigned from this committee. The CAC discussed methods of replacing her on the committee. Kindred offered to send a call for nominees with a deadline of October 28. Voting will follow with a decision by October 31.

- VII. Further Dean's Remarks. Dean Heller reported that the Provost had approved position requests and sent them on to the President. She did not know how this affected CAS. She does not know when position requests for 2022-23 will be.
