- 1. This meeting was conducted via Zoom.
- 2. The activity report for July/August was sent to the committee members prior to the meeting. The following item was discussed:
 - a. Jeff Norris inquired about item 7o swim meet safety check. Kathryn responded that her visit (during the meet) found no violations or concerns.
 - b. Joseph Torres asked if Jeff would share the pool event schedule with DPS so the department could have better insight to campus activities. Jeff replied he would share the schedule.
- Auggie and Jim McEvers attended the Michigan Colleges and University Safety Meeting at Grand Valley State University. Auggie noted the following from the conference:
 - Many campuses are concerned with the use of AI and ChatGPT creating issues of plagiarism.
 - b. Drone policies and who polices drone usage are an issue. MSUs policy was challenged in court and they lost. They now only regulate drone usage indoors.
 - c. The inventor of MicrobeCare gave a presentation of the antimicrobial product that uses covalent bonding vs alcohol to clean items for longer periods of time.

- 4. Joseph Torres noted the following items:
 - a. The police department in conjunction with the Ypsilanti Fire Department completed their Housing and Residence Life training sessions.
 - b. The campus Police Department has offered ALICE training to all departments on campus. It now plans to offer the training to any campus community member on a twice a month schedule. Please contact DPS to secure a seat in the training.
 - c. DPS is ready to welcome the campus residence back for this new academic year.
- 5. Jeffery Norris reported the following items:
 - a. The Rec IM has prepared and is ready for the start of the new academic year.
 - b. An entry glass panel, broken by a thrown rock, was replaced.
- 6. Chris Grant reported the following:
 - a. The West Circle Dr. project was completed and the traffic pattern has returned to normal.
 - Grounds team members have focused on cleaning up the campus for the new school year.
 - c. Concrete work was completed around the Student Center.
 - d. Recycle pick-ups will increase for the next few weeks as students settle into their living quarters. The increase in recyclable packaging materials necessitates this.
- 7. Kevin Lawson noted the north side patio and ramp are ready for the semester start.
- 8. Kathryn reported:
 - a. Jim McEvers is working with the fume hood repair technicians today. The Mark Jefferson fume hoods are beginning to experience chain failures which is a serious safety concern.
 - b. Jim coordinated clean outs of the chemicals in the Roosevelt lab and several flammable liquid storage cabinets in Mark Jefferson.
- 9. Kathryn Wilhoff noted an increase in meetings with various departments discussing safety issues as they get ready for the fall semester.
