With more that 50 published works and an impressive list of national and international awards to his credit, even a brief perusal of the accompanying biographies reveal the significance of Anthony lannaccone's contribution to the art of musical composition. Further, he is a beloved teacher and colleague who has profoundly contributed to the Department of Music and Dance at Eastern. Among his many achievements is a legacy of highly successful composition students, many of whom hold university teaching positions. He is the co-founder and long-time coordinator of the EMU Music Now Fest, a biennial celebration of new music that has enriched cultural life on campus and elevated the department's profile in the region. Beyond these specific achievements, for 42 years the department has benefited enormously from Anthony lannaccone's artistry, wisdom, and generosity. We wish him well in retirement and know that he will be greatly missed.

Dr. Whitney Prince Professor of Music ANTHONY IANNACCONE (born New York City, 1943) studied at the Manhattan School of Music (M.M.) and the Eastman School of Music (Ph.D.). His principal teachers were Vittorio Giannini, Aaron Copland, and David Diamond. During the 1960's, he supported himself as a part-time teacher (Manhattan School of Music) and orchestral violinist. His catalogue of approximately 50 published works includes three symphonies. smaller works for orchestra, several large works for chorus and orchestra, numerous chamber pieces, large works for wind ensemble, and several extended *a cappella* choral compositions. His music is performed by major orchestras and professional chamber ensembles in the US and abroad. He is an active conductor of both new music and standard orchestral repertory. In addition to conducting numerous regional and metropolitan orchestras in the US, he has conducted several European orchestras, including the Bohuslav Martinu Philharmonic, the Bavarian Festival Orchestra, the Janacek Philharmonic, the Moravian Philharmonic, and the Slovak Radio Orchestra. Since 1971, he has taught at Eastern Michigan University, where, for 30 years he conducted the Collegium Musicum.

lannaccone's works have won many first prizes in national and international competitions, including the Ravel Prize for RITUALS FOR VIOLIN AND PIANO, the Dutka Foundation Prize for STRING QUARTET NO. 3, the Ostwald Award for SEA DRIFT, and the SAI/C.F.Peters Award for TWO-PIANO INVENTIONS. His WAITING FOR SUNRISE ON THE SOUND was chosen as one of five finalists in the 2001 London Symphony Orchestra Masterprize competition from a field of 1151 orchestral works submitted. Several of Iannaccone's works for chamber and large ensembles have entered the standard repertory. Describing his music, The New Grove Dictionary of Music and Musicians states, "organic growth inspires music of great strength and formal clarity, as opening bars generate the textural and thematic contours that forge contrasting sections of reflection and crossrhythmic dynamism." Iannaccone has received grants, awards, and commissions from numerous institutions, orchestras, foundations, and organizations, such as the Aaron Copland Fund for Music, the National Endowment for the Arts, ASCAP, Cornell University, the Eastman School of Music, the Prague Philharmonic, the Richmond Symphony, the Kalamazoo Symphony, the Michigan Council for the Arts, East and West Artists of New York, the Tucson Chamber Music Festival, and Continental Harmony, among many others. Recent commissions include a quintet for clarinet and strings for Richard Stoltzman. a choral work for the Ithaca College School of Music, and an orchestral work for the Dearborn Symphony.

Iannaccone, Anthony (Joseph) (b Brooklyn, NY, 14 Oct 1943). American composer. He studied composition with Ludmila Ulehla, Vittorio Giannini and David Diamond at the Manhattan School of Music (1961–8, MM) and with Samuel Adler at the Eastman School (1968–71, PhD); he also studied privately with Copland between 1959 and 1964. He taught briefly at the Manhattan School (1967–8) and in 1971 was appointed professor of composition at Eastern Michigan University, where he founded the school's electronic music studio; in 1973 he became director of the Collegium Musicum. He has received awards from the NEA, the Phi Mu Alpha Sinfonia Foundation, and other organizations.

After an early phase of nearly orthodox serialism from 1967 to 1975, his music diverged into what the composer described as 'small-audience' music - abstract and intense works such as Mobiles for brass and percussion - and 'large audience' music, wherein melody and cohesiveness are paramount and characterize works such as the Divertimento (1983) and much of his vocal and windensemble writing. His craft reaches its zenith in his synthesis of the two styles in the Two-Piano Inventions, which won the SAT/C.F. Peters competition in 1990, and the Third Symphony; in both these works, organic growth inspires music of great strength and formal clarity, as opening bars generate the textural and thematic contours that forge contrasting sections of reflection and crossrhythmic dynamism. In addition to the impact of Stravinsky, Bartók and Debussy, the poetry of Walt Whitman has proved a frequent source of inspiration, culminating in his Third Symphony with its effective imagery of Whitman's metaphors of night and rivers.

Professor Leapard passed away April 26, 2013 after a recurring battle with cancer. Professor Leapard was much beloved by both her students and faculty colleagues—she will be deeply missed.

I want to recommend Professor Barbara Leapard for emeritus faculty status posthumously—she is most deserving of this honor.

Professor Leapard was a truly phenomenal teacher and mentor. One of her students wrote,

"While I love learning and the thought of teaching excited me, I was honestly very apprehensive about the thought of teaching mathematics. I had always been fairly proficient at math as a student, but I realize that I was more a "show me the algorithm and I can plug in the numbers and come up with the correct answer" rather than one who understood the concepts well. The thought of having to explain my cognitive process in solving a math problem to students, or figuring out how to help them understand difficult concepts, made me very nervous. Dr. Leapard changed my apprehension into excitement."

Over her career, Professor Leapard helped even the most reluctant mathematics student become excited about mathematics and teaching mathematics. Her enthusiasm was contagious.

Professor Leapard began her career at Eastern Michigan University in the Department of Mathematics as a lecturer in 1993, and became a tenure track faculty member in 2000. She taught graduate and undergraduate mathematics and mathematics education courses for elementary and secondary teachers. Professor Leapard was our "go to" technology person—always current on new technology for teaching mathematics more meaningfully, and always excited to share her expertise with her colleagues.

In 2003, Professor Leapard was awarded the Ronald W. Collins Distinguished Faculty Award for Teaching. Additionally, Dr. Leapard was a frequent speaker at local, state and national conferences for mathematics educators, provided consultative services for K-12 schools, participated in the development of research grant proposals, and was involved in a number of student research projects.

A memorial scholarship is being established at Eastern Michigan University, Ypsilanti, Michigan, in Barbara Bennett Leapard's name.

It is without hesitation that I highly recommend that Dr. Barbara Leapard be awarded emeritus faculty status.

RE: Nomination of Vannie Kay Hodges for Emeritus Professor

Dr. Hodges served as Professor of Psychology at Eastern Michigan University from 1989 until her retirement in October, 2012. While at EMU, Dr. Hodges received almost 1.5 million dollars in external funding in the areas of children's mental health, evaluation of treatment outcomes, and implementation of evidence-based treatments. During her entire tenure at EMU, her research supported one to two masters' level students per year as graduate assistants, with a number of students progressing on to obtain doctoral degrees at other universities. She brought to EMU a research project that was one component of an NIMH-funded grant, "Assessing Treatment Effectiveness and Family Empowerment," which lasted from 1990 to 1994. From 1996 until her retirement, Dr. Hodges received annual funding from the Michigan Department of Community Health to evaluate outcomes for children and adolescents who received mental health services from the Department. Michigan became a model for data-driven decision making at the state and agency levels. Initiatives related to program development and staff training were in part shaped by the statewide outcomes data available to decision makers. Dr. Hodges became nationally recognized for her expertise in this area, along with her collaborators at the state level.

During her professional career, Dr. Hodges had over 200 papers accepted for presentation at national and international conferences. Her publications included 47 research articles in peer-reviewed journals and over a dozen chapters. Her last few works focused on the importance of using outcome data, collected on each client served within the system, to guide practice improvement and to maintain a culture of accountability. She also wrote about how to implement and sustain an outcomes management orientation. With collaborators at the National Technical Assistance Center for Children's Mental Health at Georgetown University, she co-authored a chapter on the importance of implementing this approach with a system of care, which includes the various agencies serving children, such as mental health, juvenile justice, child welfare, education, and health care.

Dr. Hodges was also committed to service within the University and the broader community. She was hired to serve as Director of Clinical Training in Psychology for the master's level graduate programs, which she did from 1989 until 1996. She served on numerous committees within the department and was active within the Institute for the Study of Children, Families, and Communities. At the state level, she served on committees related to research and implementation of evidence-based practices in mental health. At the national level, she is a fellow of the American Psychological Association (APA), was appointed to the APA Task Force on Serious Mental Illness and Severe Emotional Disturbance, and served on the executive committees for the APA divisions of Clinical Psychology and Child, Youth and Family Services. She was also active in the area of internship training at the doctoral level, as a site visitor for the APA Committee on Accreditation and as the associate editor of the Association of Psychology Internship Centers Newsletter. She was board certified, becoming a Diplomate in Clinical Psychology awarded by the American Board of Professional Psychology in 1982, and later serving as an Examiner for the American Board of Professional Psychology.

She enjoyed teaching in the areas of abnormal psychology, at the undergraduate and graduate level, and psychology of women, in which she taught in the honors program. Dr. Hodges deeply enjoyed

serving as a mentor and teaching students at EMU, as she was proud to serve at an institution that is truly devoted to excellence in teaching. Early in her career at EMU, she received an award for her scholarly activity, for which she was very appreciative.

Dr. Hodges received her B.A. from Duke University with the distinction of Phi Beta Kappa, her Ph.D. in Clinical Psychology from the University of Maryland, and interned at Children's Hospital in Washington, D.C. Prior to joining EMU, she was on the faculty of the departments of psychiatry in the medical schools at Duke University and the University of Missouri, where she also served as director of training for an APA-approved Psychology Internship.
