SUBJECT: Recommendation for Staff Emeritus Status – Kathleen Tinney

We are recommending Kathleen Tinney for recognition as an emeritus staff nominee. Ms. Tinney retired in 2005 after 34 years of service to Eastern Michigan University in many diverse roles including associate vice president for University Relations (2003-05), assistant vice president for University Relations (1991-2003), director of communications (1982-1991), director of public information (1980-82), news bureau manager (1975-80), associate publications editor (1970-75), and assistant publications editor (1968-70).

In addition, Ms. Tinney served in special university assignments as interim director of development (1992-94), affirmative action officer, University Relations (1980-89), member of several significant committees from strategic planning to contract bargaining teams. Further, Ms. Tinney served as primary university press spokesperson for nearly 20 years. Most importantly, Ms. Tinney always represented the university with great integrity, upholding the highest standards of ethical behavior.

Following her retirement in 2005, she continues to be actively supportive of Eastern Michigan University with her attendance at EMU men's and women's athletic events, her volunteerism and financial commitments to WEMU and her contributions to the EMU Foundation scholarship program.
