2. Name of the bank on letterhead or bank seal with signatures
3. Account Holder
4. Account Type (Checking, Savings, Current, Private, etc.)
5. Type of Currency
6. For Fixed Deposits, statement must list maturity date (must be before planned academic start term) or that the funds are able to be withdrawn without penalty
7. Screenshots of account details will not be accepted
