Doris: Assessment reports were overall better this year, with clearer discussions of "closing the loop."

We discussed highlights and challenges from the reports this year. It was generally agreed that the template was clearer this year. COVID was obviously a significant challenge last year—with fewer programs and instructors participating—and will be going forward as we seek to a) evaluate how we're doing with online teaching and b) carry out assessment online.

Comprehensive Site Visit October 21, 2021 (Final Report submitted by July/August 2021)
Criterion 4, Core Component 4B (revised criteria)

Usually the report is due August 31; we should have our final draft of the Criterion 4 finished in July for everyone's review.

This is a four-year check-in, not for accreditation.

### **Criterion 4 Requirements:**

- A. The institution ensures the quality of its educational offerings.
- B. The institution engages in ongoing assessment of student learning as part of its commitment to the educational outcomes of its students.
- C. The institution pursues educational improvement through goals and strategies that improve retention, persistence and completion rates in its degree and certificate programs.
