Requirements for Withdrawal

Students who are withdrawing from all classes at the University must notify the Registrar's Office by following specific withdrawal procedures posted in the Student Guide: www.emich.edu/registrar/registration_info/withdrawing.php

Return of Federal Financial Aid

The federal government mandates that students who withdraw from all classes may only keep the financial aid (federal Title Iv grant and loan assistance) they have "earned" up to the time of withdrawal. Campus Safety and Security

EMU Department of Public Safety (DPS) patrols the campus area, in addition to the SEEUS walking escort service to guide student's safety at night.

The EMU Police Department is a fully functioning, professional police department with full law enforcement capabilities. The Police Department is located at 1200 Oakwood Street and is open 24 hours a day, seven days a week, to serve the needs of the campus community. The department is comprised of seven sergeants, thirty sworn police officers, and eight dispatchers.

All of our police officers are certified through the Michigan Commission on Law Enforcement Standards (MCOLES). As sworn officers, they are empowered to investigate crimes and make arrests or take other necessary action to address any criminal or other public infractions in the vicinity of the EMU campus. EMU police officers work closely with all area police agencies, including the Ypsilanti Police Department, Michigan State Police and Washtenaw County Sheriff's Department.

The Eastern Michigan University Police Department prepares an Annual Security Report to comply with the Jeanne Clery Disclosure of Campus Security Policy and Crime Statistics Act.

This report is prepared in cooperation with the Housing and Student Judicial Services Departments. Each entity provides updated information on their educational efforts and programs to comply with the Act.

Family Educational Rights and Privacy Act (FERPA)

The Family Educational Rights and Privacy Act (a.k.a. FERPA or the Buckley Amendment) is federal legislation enacted in 1974 that controls student records. It grants students the right to access their own educational records as well as limiting, for privacy reasons, the release of those same records to anyone other than the student and/or the student's designee. FERPA applies to all current and former students of the University.
