Undergraduate Conference in Philosophy

EMU's 13th Undergraduate Conference in Philosophy (UCiP) welcomed students from across North America to EMU for a lively weekend of philosophical discussion and conviviality. Paper presentations ranged across numerous subfields of philosophy, with topics spanning hope and agency, resentment and moral identity, the conditions of meaning, and philosophical issues relating to algorithms and gender theory. New riffs on ancient thinkers and still-debated topics—such as Aristotle, Confucius, Nietzsche, and consciousness—were part of the mix as well. It is a joy to hear interesting philosophical arguments and ideas combined in novel and exciting ways. The conference continues to be an important event each year for EMU's philosophical community, and we're very pleased to contribute to philosophy in this way.



UCiP's keynote speaker this year was **Dr. Brynn Welch** (University of Alabama at Birmingham). Dr. Welch's talk, "Is There Such a Thing as a Good Parent?," provoked a lively and substantive discussion. We thank Dr. Welch for her time and philosophical insights. She joins a long line of terrific speakers who have shared their work at UCiP over the years.

Faculty News

Professor Brian Bruya published Ziran: The Philosophy of Spontaneous Self-Causation (SUNY Press) and its Chinese companion version 《自然与智慧----中国古代思想对现代科学与教育的启示》(Translated by Ma Aiju and Ye Da; People's Press), a collection of lectures delivered at Shandong University in China and National Cheng-Chi University in Taiwan. The book summarizes Dr. Bruya's work on the early Chinese notion of ziran 自然 (spontaneity/self-causation/autopoiesis...) and its usefulness in thinking through long-standing issues related to action theory and aesthetics in Western philosophy. Dr. Bruya is looking forward to teaching the M.A. pro-seminar this fall and plans to teach



a free, non-credit-earning course on beginner's level Classical Chinese language (no prior exposure expected or required) and to start a personal self-improvement club called Go Cultivate Yourself. All levels of students are welcome in the Classical Chinese course. Go Cultivate Yourself is open to students, staff, and faculty, while being aimed primarily at students. He hopes to see you at one or both of them!



Professor Jill Dieterle published two articles in the last academic year. The first, "Identity and Food Choice: You are What You Eat?" (*Food Ethics* 8 (2023): 1-17), was co-authored with former Philosophy major Zachary Tobias. The second, entitled "Other-Oriented Hermeneutical Injustice, Affected Ignorance, or Human Ignorance?" is forthcoming in *Social Epistemology*. (Jill seems to like titles with question marks!) She is currently working on a project on epistemic injustice, disability, and objectivity with Professor John Koolage and Joah DeCasas, a graduate of the EMU Master's program in Philosophy. Jill is looking forward to the Fall 2023 semester, during which she will be teaching two of her favorite

classes: PHIL 224 Ethics and Food and PHIL 427W/527 Social Epistemology.

Professor Peter Higgins continued in his role as Department Head of History & Philosophy in the 2023 academic year. It was a busy year due to the (very successfully concluded) faculty search in Modern philosophy and a major gift to the department to support the creation of an Institute for Civic Education. Professor Higgins also learned that he is a skilled department secretary, but was pleased to relinquish that role in late February. In scholarly news, Professor Higgins completed revisions on an article, "Gender and Migration," co-authored with Amy Reed-Sandoval for the Handbook of Migration Ethics, forthcoming from Springer.





Professor John Koolage's research agenda for last year included a fair amount on work regarding leadership in Higher Ed, including co-written publications on building community in leadership positions in *The Department Chair* and shared governance in *Liberal Education*. His paper (co-written with EMU M.A. graduate Natalie Anderson), "Addressing the Deep Roots of Epistemological Extremism," appeared in *Teaching Philosophy* (vol. 46, no. 3). He was also fortunate to have his work, "Flatten that hierarchy: everyone wins when we teach (and learn) together," included as a chapter in Dr. Brynn Welch's forthcoming book, *The Art of Teaching Philosophy*. Two *Liberal Education* web exclusive articles (where Professor Koolage is one of several authors) are

available online: one is on reimagining the leadership pipeline and the other is on professional service. As for presentations this year, Dr. Koolage presented as a member of a book panel, which included EMU philosophy's newest addition, Dr. Kris Phillips, at Cogteacho. He also shared his thoughts on 'should we trust the science' in Gabe Kasper's Pubology series. He enjoyed teaching and learning with students in Philosophy of Mind and Philosophy of Science last year. He was especially taken by philosophy of archeology, and looks forward to sharing this area of philosophy of science with anyone who will listen. Also, revisiting 4E Cognition was a true joy! He is excited to teach and learn with students this coming year, and hopes many will join the group for Philosophy of the Life Sciences in the Winter.

This past year **Professor Laura McMahon** was on sabbatical. In addition to carrying on her research project on phenomenology and political transformation, she enjoyed trips to Toronto, Arizona, Mexico, and Italy, all with a one-year-old in tow. Professor McMahon has two new book chapters forthcoming in edited volumes: "The Virtue of Vulnerability: Merleau-Ponty and Minuchin on the Boundaries of Personal Identity" (forthcoming with Bloomsbury in *Philosophical Health: Thinking As a Way of Healing*) and "Existentialism and Political Transformation: Sartre on the Ambiguities of Freedom and *Praxis*" (forthcoming in *The Routledge Companion to Contemporary Existentialism*). She also gave invited talks at the University



of Cincinnati and the University of Guelph, and continued her tenure as President of the Canadian Society for Continental Philosophy and as Secretary-Treasurer for the Society for Phenomenology and Existential Philosophy. Professor McMahon is excited to be back on campus and in the classroom this coming year!



Professor Kate Mehuron completed two papers this past year on the concept of moral injury, examining the connections between philosophical and clinical perspectives. She presented "Self-Betrayal and Moral Repair" to the IAFOR International Conference on Arts & Humanities in January 2023, subsequently publishing this paper in the IAFOR proceedings. She presented a companion piece, "A Case of Moral Injury in Global Context: How a Remorseful Address to Migrant Communities Fails in Moral Repair," to the Twenty-first International Conference on New Directions in the Humanities in May 2023. Professor Mehuron is also an Academic Associate Faculty in the Michigan Psychoanalytic Institute (MPI), an honorary position that invites her to ongoing *pro bono* educational activities at the Institute. In Fall 2022, she designed and instructed the four-week seminar, "Moral Injury: Philosophical and Psychoanalytic Perspectives," for clinical candidates in the Adult and Child/Adolescent Advanced Psychodynamic Psychotherapy Program, a subsidiary training program of MPI. All of these educational and research activities are part of Professor Mehuron's ongoing practice, as a certified philosophical counselor (American Philosophical Practitioner Association) and certified academic psychoanalyst (Michigan Psychoanalytic Institute). To deepen her practice, Dr. Mehuron participated in a five-month practicum in Fall 2022, "Philosophical Counselors Connect," under the sponsorship of the APPA.

Professor John Ouko presented a paper titled "Wangari Maathai and the Green Belt Movement: A Reassessment of Ecofeminism, Development and Environmental Crisis" at the 10th Asixoxe–Let's Talk! Conference on African Philosophy held at the Institute of Philosophy of the Czech Academy of Sciences (Prague) and Centre of African Philosophy, University of Bayreuth (Germany), in June 2023. He also presented a paper titled "The Relevance of African Communal Values to Environmental Sustainability" at the Great Lakes Bioneers Detroit 17th Annual Conference held at the University of Detroit Mercy in October 2022. Additionally, Professor Ouko presented a paper titled



"From Negative Peace to Positive Peace: Insights from Martin Luther King Jr" at the Martin Luther King Jr. Academic Programs Conference held at Eastern Michigan University in January 2023. Professor Ouko also served as a judge for the 2023 Michigan High School Ethics Bowl that took place in February. In addition to the above, Professor Ouko peer reviewed articles for the following journals: International Journal of Environmental Research and Public Health (February 2023), and Religions (October 2022 and June 2023).



Professor Michael Scoville continued work this past year on two main research projects, each of which connects to his teaching in environmental philosophy and ethical theory. One project is focused on identifying and analyzing different concepts of nature at play in environmental theory and policy discussions. An essay related to that project, "On the Concept of Independent Nature," is forthcoming in *Environmental Philosophy*. The second project explores pluralistic accounts of value and practical reason, and considers the resources those accounts offer, in particular, for illuminating and adjudicating cases of conflict and disagreement about environmental values.

Apart from his research and teaching, Dr. Scoville will continue to serve as Chair of the Philosophy Section, in addition to serving on several committees connected to the Philosophy program. He will also maintain his extensive involvement with the Environmental Science and Society (ENVI) program, serving as Co-coordinator for ENVI, as a member of the ENVI Steering Committee, and as the advisor for the Environment and Society Concentration within the ENVI major. He is looking

forward to another year of working with students, of serving the EMU academic community, and of making progress on his research projects.
