

# F-2 Dependent Affidavit of Financial Support

Students in valid F-1 status may choose to have their spouse and unmarried minor children (under 21 years of age) accompany them to the United States or join the student at a later date. The dependent family members will be given F-2 status provided they establish to the satisfaction of the U.S. Consular and Immigration Officer that they have sufficient funds to cover their expenses while in the U.S. and that they intend to depart the U.S. upon the completion of the F-1's status. In order to issue a Form I-20 for the dependent(s) to obtain F-2 status, OISS must receive evidence of sufficient funding for the first year of the dependent's stay in the U.S., as well as an agreement from the financial sponsor that they will continue to provide funding throughout the duration of the F-2 dependent's stay in the U.S. All financial sponsors, including the F-1 student (if providing financial support), must complete this form and provide OISS with an official bank statement or letter as evidence of liquid funds. The financial sponsor must provide documentation showing they have access to \$6,325 USD per dependent.

#### Acceptable Documents Must Include:

- Official bank statement or letter with bank seal and/or bank letterhead visible
- Type of account must be listed all funds must be liquid (i.e., funds must be held in a checking or savings account)
  - Fixed/Term Deposits must have a past maturity date or must indicate that the funds are able to be withdrawn without penalty
- Statement date statements must be less than one year old
- Name of account holder
- Type of currency
- · All statements must be in English

### OISS Will NOT Accept\*:

- Any type of investment or investment account
- Screenshots of online accounts
- Mutual funds, student loans, real estate holdings, company accounts, or any similar account deemed to not be a
  personal account
- Fixed/Term Deposits that have a future maturity date
- Any other type of account that is determined to not be liquid

\*OISS reserves the right to determine the validity of submitted documentation. If OISS cannot verify the validity of provided documentation, OISS reserves the right to deny the student's request for a dependent I-20.
