# **Research Projects**

"The Development of Russian Civil Society." This project began in 2007 and has been supported by a Fulbright grant to conduct research in Samara, Russia. It seeks to assess the way in which various factors, including the state, international organizations, and access to resources affect the character and performance of non-governmental organizations in Russia. Collection of information about specific organizations was conducted in Samara in 2007 and supplemented through library and archival research at the University of Illinois in Summer 2009. A sabbatical leave award from EMU in 2011-2012 has provided the opportunity to complete a book manuscript on the path of democratic development in the Russian Federation.

"The Development of Russian Representative Institutions." Work on this project began in the early 1990s and is continuing at present. Data has been gathered from primary sources and through direct observation and interviews with actors in the field at both the national and local levels, including interviews with members of the St. Petersburg Legislative Assembly. The results of this project are presented in my book manuscript *From Soviets to Parliaments? The Development of Russian Legislative Institutions* which will be completed in 2012.

"Structural Change and Local Democracy in Post-Communist Societies." Coinvestigator: Samuel Eldersveld of the University of Michigan. The goal of the study is to examine the relationships between structural change, elite behavior, elite values, and the development of democratic institutions at the level of the local community in former communist societies. Data used in the analysis were gathered by the international research project

"Democracy and Local Governance," in which scholars in more than twenty countries have surveyed local elites across the last decade. Professor Eldersveld and I gathered data in the United States in 1984 and 1988.

"The Elite Paradigm and the Study of Transformations in East-Central Europe." The goal of this project is to construct a theoretical framework to account for variation in observed patterns of elite transformation. The central independent variable is the pre-transition institutional context. The first product of this work appeared in the April 1996 issue of the *Journal of Democracy*, the second in *Elites and Leadership in Russian Politics*, edited by Graeme Gill, and the third in the forthcoming *Studies in Public Policy* article.

Participant in the "The Russian Election Study" of the Harvard University Russian Research Center, directed by Timothy Colton and Jerry Hough, November-December 1993. During the election campaign, I conducted interviews, gathered party information and campaign material, and observed party meetings, rallies and public appearances of the candidates in Moscow. My analysis, "Preserving the Radical Stronghold: The Election in Moscow" was published in *Growing Pains*, edited by Colton and Hough.

"Elites, Political Parties, and Democratization in Contemporary Russia." This project examined alteration of elite structure, patterns of elite political behavior, and the nature and problems of political parties from the late *perestroika* period to the present. Supported by a Hoover Institution Title VIII post-doctoral fellowship.

"Domestic Political Attitudes and Foreign Policy Preferences of Soviet Elites," a collaborative project between a team from OSU (Charles Hermann, Saundra Jones, Judith Kullberg), scholars from the Soviet Peace Committee (Andrei Melville and Aleksandr Nikitin), and from the Institute of Sociology of the USSR Academy of Sciences (Elena Bashkirova). Funded by the Mershon Center at Ohio State with support from the McArthur Foundation. Focus group interviews were conducted in Moscow during the second and third weeks of June 1991. Results appear in the *Europe-Asia Studies* article.
