It is my pleasure to submit this recommendation requesting the Board of Regents consider granting emeritus staff status to Glenna Frank Miller. Glenna joined Eastern Michigan University as at PT05 Residence Hall Director in the fall of 1974. She continued in a number of roles, most recently as Assistant Vice President of Student Life. Over the course of her 39-plus years at EMU, Glenna was involved in the following:

- The EMU Student Center opening in 2006
- The VISION Center starting in 1990 with 6 years of AmeriCorps grant funding from 1994-2000
- The EMU Orientation Program started in 1983
- The EMU Martin Luther King, Jr. Day/week programs starting in 1987
- The EMU leadership conferences starting in the late 70's and changing to the LeaderShape leadership development model in 2001
- Membership on the Student Affairs Committee of the Board and support for the Student Leader Group from the mid-1980s
- Membership in the General Education Reform initiative with the Learning beyond the Classroom component implemented in 2007
- Development of the general fee funding and delivery model and innovative programs for Campus Life, Diversity and other programs, activities and services.

Glenna also participated in the major Student Affairs professional associations such as NASPA, ACPA, ACUHO-I, NODA and ACUI. The national student center renovation/construction conference was hosted here at EMU, along with the national collegiate poetry slam, and several MAC Union Directors events as well.

Glenna has devoted her professional life to furthering student interests at EMU, and has been dedicated to the mission and values of this institution. I strongly recommend that she be granted emeritus staff status. Thank you for your consideration.

Emeritus Staff Recommendation Glenna Frank Miller Retiring June 30, 2013 from the Division of Academic and Student Affairs

Dear Chairman Parker and EMU Board of Regents,

I am delighted to submit this recommendation requesting the Board of Regents grant emeritus staff status to Glenna Frank Miller. Glenna has committed 39 years of her professional life to Eastern Michigan University, and to providing an outstanding experience for all students. She is a consummate Student Affairs professional, who has profoundly and positively impacted the lives of thousands of individual students at EMU.

As Director of Campus Life, Glenna designed and implemented Eastern's first orientation program model some 25 years ago. New Student Orientation is a flagship institutional program that not only successfully transitions new students into EMU, but also infuses the entire institution and its newest members with school spirit and pride, while providing the foundational piece of the student leadership development experience at EMU. New freshmen witness the leadership role of upper-class students involved in orientation, while engaging in all the myriad elements of this four day program. Given an average of 2000 new freshmen per year, over 25 years Glenna's student transition model has shaped the very first experiences on campus for some 50,000 new freshmen. From the ranks of upper-classmen, approximately 150 student leaders volunteer as New Student Orientation Assistants each year, contributing nearly 10,000 hours of service to the institution annually, and gaining leadership skills, which inform their other involvements including participation in student organizations and student governance. Over the course of 25 years, that adds up to 3,750 students who have gotten their first taste of service to others under Glenna's watch, and 250,000 hours of student volunteer service to EMU that has taken place with Glenna's guidance.

Glenna's legacy of developing students to be leaders extends well beyond freshmen orientation to include 25 years of producing intensive annual leadership development conferences providing opportunities for 50-60 students per year to engage over several days with senior administrators, faculty and staff at EMU. These high impact learning experiences have not only made a difference to the individual students involved (1250 of them), but also have made a tremendous positive contribution to the entire collegiate environment at EMU, by supporting the student leaders who make campus come alive through their initiatives.

When one considers the advisory role Glenna has had with additional student leadership teams including the Student Affairs Committee to the Board of Regents (Student Leader Group), Student Government, RHA during her tenure in Residence Life, the Campus Life Program Board during her many years with Campus Life, the student employees in the Student Center and McKenny Union, as well as leaders of some 270 student organizations each year, one begins to see the breadth and extent of her engagement and connection to students and her singular role in their personal development.

In addition to the impact Glenna has made in the individual lives of student leaders, Glenna has been instrumental in envisioning, advocating and cultivating a rich, vibrant collegiate environment at EMU. She

developed the proposal for EMU's first student general fee, which passed in 1995 and provided a means to fund a broad array of student activities at EMU, including major concerts, a professional performing arts series, guest speakers and lectures, excursions off-campus, movies and late night programming events, leadership programs, Greek Life events, commuter services, multicultural programming, lgbt activities, and so much more. Glenna successfully initiated and institutionalized VISION, EMU's student community service office, which actively engages students in service to the community; this one dimension of student life was instrumental in EMU's achievement of earning Community Engagement Classification from the Carnegie Foundation For the Advancement of Teaching.

Glenna's collaborative nature has influenced the institution in many ways as well. Her support and partnership with Academic Affairs brought about the inception of the Academic Service Learning program, now an integral part of the way we teach, and helped EMU garner major grants from America Reads and Jumpstart, further integrating students into the community to serve as educators. She planned the first MLK Day President's Luncheon at the behest of then President John Porter, and then in partnership with faculty and Academic Affairs administrators, expanded that event to an annual weeklong celebration with many traditions that continue to this day. The EMU Student Center is perhaps Glenna's greatest vision and collaborative venture, working hand in hand with Plant Operations, Business and Finance, student leaders, and other units throughout campus. This project was truly a labor of love, and the facility has made a profound impact on student life at EMU.

Finally, I would add that Glenna has served as a tremendous mentor, guide, and model to many, many professional staff members and graduate students in the field of Student Affairs. She has served the profession exceptionally well, and contributed to our institution through investing in and strengthening the human capital here. She is highly regarded and respected both on campus and throughout the state as a leader -- she has represented the institution extremely well, always putting the needs of students first, and modeling integrity and respect for others.

I ask that you please confirm Glenna Frank Miller's application for emeritus status; she has certainly earned this distinction, and I know it would be an exceptionally meaningful honor to her.

It is an honor to nominate Gregory Peoples for emeritus status with our institution. He has served with distinction for over 28 years and the lives of students, staff and faculty are better for it.

Greg started in admissions, left for a few seconds, and came back to Eastern as the Associate Dean of Students, ascended to the Dean's role and then became our Ombudsman. Through all of that time he has kept a singular focus on the well-being of students. More importantly, he has always sought to give them what they need, not necessarily what they want. He has been called on to meet with families when they have lost a child, whether on campus or not, and taken it upon himself to go to the hospital and funerals. His compassion and caring are unmatched.

Greg Peoples has been a distinguished staff member and administrator who has been dedicated to enhancing the students' educational experience. He received his baccalaureate degree from Allegany College in 1973 and his masters degree from Kent State University in 1977.

Greg has fulfilled several important staff roles during two periods of time he was employed at EMU, totaling more than 28 years of service.
