Regent Crumm convened the meeting at 9:30 a.m.

Report and Minutes (Section 10)

Regent Crumm requested that the Educational Policies Committee Agenda for December 8, 2015 and Minutes of the October 13, 2015 meeting be received and placed on file.

Emeritus Faculty (Section 5)

Dr. James Carroll, Associate Provost and Associate Vice President for Administration, recommended that the Board of Regents grant Emeritus Faculty Status to three (3) former faculty members: Carol Haddad, School of Technology and Professional Service Management, 1993 to 2015 (who retired August 2015 after 22 years); Joanne Hansen, Halle Library, 1965 to 2015 (who retired September 2015 after 50 years); Andrew Nazzaro, Department of Geography and Geology, 1969 to 2015 (who retired August 2015 after 45 years).

STAFF SUMMARY

The Collective Bargaining Agreement between Eastern Michigan University and the Eastern Michigan University Chapter of the American Association of University Professors (AAUP) provides that a faculty member who has served the University for at least fifteen (15) years may be nominated for Emeritus Faculty Status upon retirement.

The nominations for these individuals have received the support of the department head or school director, the dean of the college, and the Provost and Executive Vice President.

Academic Affairs Administrative Appointments/Professional Appointments and Transfers (Section 6)

Dr. James Carroll, recommended that the Board of Regents approve (3) Administrative/Professional transfers at the rank and effective date shown on the attached listing.

FISCAL IMPLICATIONS

The salary would be absorbed in the 2015-2016 personnel budget.

Charter Schools Board Member Appointments (Section 11)

Dr. Malverne Winborne, Director of Charter Schools, recommended that the Board of Regents appoint Kenneth Sherman to a three year term to the Board of Directors of Ann Arbor Learning Community; reappoint Rupert Cannonier to a three year term to the Board of Directors of Commonwealth Community Development Academy; appoint Danielle Johnson to a three year term to the Board of Directors of Detroit Public Safety Academy.

STAFF SUMMARY

According to the resolutions which establish these public school academies (charter schools), vacancies on the Boards of Directors shall be filled by the Eastern Michigan University Board of Regents.

New Policy: Degree Requirements Policy (Section 12)

Dr. Rhonda Longworth, Associate Provost and Associate Vice President for Academic Programming and Services recommends that the Board of Regents approve a modification to Board of Regents policies 6.1.1, Degrees, Certificates and Requirements for Graduation.

SUMMARY

The proposed policy revisions would allow for the creation of a Bachelor of General Studies degree award for students completing the Individualized Study Program. The policy language is also updated to incorporate other past actions on degree awards. The proposed revisions would also eliminate the degree level requirement to complete an academic minor. These changes are designed to support timely degree completion for students and offer degree programs that compare favorably with those offered by geographic peer universities. They also support greater program-level direction of curriculum development efforts.

Discussion Items:

Dr. Rhonda Longworth provided an update on the Degree Completion and Retention Plan. She highlighted the Holman Success Center as a key component of retention at EMU.

Dr. Mary Brake, *Interim Associate Dean of the College of Technology* presented a College of Technology College profile.

Regent Crumm thanked those in attendance, and adjourned the meeting at 10:05 a.m.
