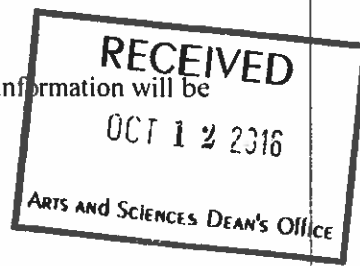



Dr. Callaway joined the faculty at EMU in 1992 where she served as a member of the Counseling faculty. Sadly, Dr. Callaway died unexpectedly on August 16, 2015. Yvonne absolutely relished her teaching at Eastern. She gave of herself so willingly to her colleagues, her university, and her students. Professor Callaway's interest and expertise was in diversity, group work, and group based school counseling. She was a sought-after speaker, providing presentations at national and local conferences and on numerous occasions served as a consultant to Oakland schools.

While Yvonne primarily taught graduate level courses, she often worked with, advised, and assisted many undergraduate students who never had her as an instructor. She was a fearless advocate who went the extra mile and fought tirelessly for their success. Her personal encouragement, her nurturing, and her extra academic support were the reasons so many students sought her out for support.

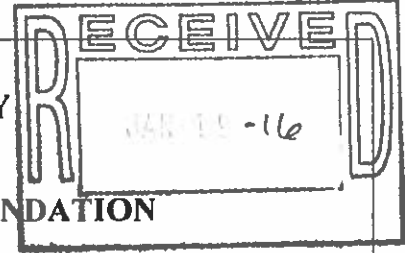
Dr. Callaway was a valued member of our department and it would be most appropriate if we could honor her in this way.

I am requesting that Dr. Timothy Carroll be awarded Emeritus Faculty status. He earned a B.S. from the University of Michigan in 1966, an M.A. from Western Michigan University in 1969, and his Ph.D. from Western Michigan University in 1973. He will retire on August 31, 2016, after 30 years of service.

Dr Carroll came to Eastern Michigan University as an Associate Professor after working at Chicago State University and Bloomsburg University. Prior to those positions, he also worked in the banking industry. During her 15 years in our Department Dr. Chamberlain has excelled as a teacher, scholar, and colleague, earning promotion to Full Professor and the admiration of her students and peers. John Chandler Dugger, III

John Dugger arrived at EMU from Iowa State in 2000 to serve as the Dean of the College of Technology. During his 6 years as Dean, the Technology doctoral program was launched and so too were the Technology Management Program, the Aviation Flight Technology Program, the Center for Regional & National Security and the Product Research/Development Center. He oversaw a college reorganization where three programs along with the Textiles Research/Training Institute, all from another college, were absorbed by the COT and formed into two schools and one department. During his time as Dean, international agreements were signed with universities in China, France, India and Taiwan and many articulation agreements were forged with Michigan community colleges. Research funding proposals and awards grew during his tenure while five programs received accreditation approvals. Student and faculty involvement and external engagement opportunities were expanded as well. In 2003, Dr. Dugger also was the founding trustee for Epsilon Pi Tau which serves as the honorary fraternity for the College of Technology.

Upon returning to the faculty in 2007, while incorporating teaching with doctoral-student mentoring, Dr. Dugger served as a consultant and trainer for both the Office of Continuous Improvement and Planning and the Division of Student Affairs & Enrollment Management. He has served as the dissertation committee chair for 28 doctoral students including 13 from EMU and 15 from Iowa State. His scholarly record includes more than 50 published refereed manuscripts and more than \$2.1 million in grants. Over a period of 20 years, John has been a reviewer and team chair for both ATMAE and the North Central Association's Higher Learning Commission.

Dr. Dugger has coordinated the Technology doctoral program for the most recent four year period. From 2009 until 2016 he served as the Affiliate Director for Michigan Project Lead the Way. During this time, the annual training enrollment increased from 40 participants to 330, while the annual budget increased from less than \$70,000 to more than \$600,000.

It is recommended by the University Library Personnel Evaluation Committee (PEC) that longtime library faculty member Walter Hogan be granted Emeritus Faculty Status.

Professor Hogan retired this August after thirty two years of service to the Eastern Michigan University community. He served as the Coordinator for Technical Services since the start of his EMU tenure in 1984. In the following decades he was instrumental in the successful transition of the print card catalog to EMU's first integrated library system NOTIS in the late 1980s. He led the migration from NOTIS to the current Voyager system in the late 1990s, while assisting in the physical move of the print collection from the previous library building (now Porter) to the current Bruce T. Halle Library. He was a key member of the library's acquisitions and interlibrary loan operations providing exceptional leadership and guidance through the budgetary and technical challenges faced by the library during tumultuous times. Professor Hogan was a noted scholar within the University Library as an author of three books, numerous journal articles and hundreds of book reviews. He was also dedicated to the university community with significant service contributions; perhaps his most substantive university service being his many years as the library's representative to the various iterations of the campus Sabbatical Leave Review Committee. He also led many library committees and was a pillar of continuity supporting the library's Personnel Evaluation Committee, and consequently his library faculty colleagues, for decades. As an exemplar of professional performance, scholarship and service he is most deserving of this honored status.

In summation, the PEC would like to convey our enthusiastic endorsement to grant Professor Hogan the Emeritus title.

Emeritus faculty status would not only acknowledge Dr. Kasenow's numerous contributions over his exemplary 27-year career at Eastern but would enhance our program and department status by having him remain an official part of our professional group.

Dr. Kasenow has distinguished himself in teaching, research, and administration.

Dr. Kasenow joined the faculty in September 1989 and immediately set about developing a new major in hydrogeology, a program designed to train geologists in environmental issues. This program has evolved into a concentration that a quarter of a century later is one of the corner stones of the Earth System Science programs.

He developed new courses in hydrology, hydrogeology, groundwater modeling, contaminant hydrology, aquifer analysis, and a field course in wetland studies. In addition, he taught 13 other departmental courses. He was a pioneer in online course development. His courses, both in-the-classroom and online, were some of our department's most popular courses.

Dr. Kasenow has an outstanding international record of research and publications. He wrote the books and programs used by many professionals for various aspects of aquifer analyses. During his tenure at Eastern he authored or co-authored 17 books, 14 software programs, 12 monographs, 15 journal articles, and 8 abstracts. He has also given numerous invited lectures over the years.

Dr. Kasenow served as department head from 1999 to 2002. He chaired the Personnel and Finance Committee for several years and was the hydrogeology research director of the Southeastern Regional Groundwater Education in Michigan Center.

In conclusion, The University should honor Dr. Kasenow's distinguished career by awarding him emeritus faculty status.

Dr. Marz subsequently achieved her M.S. in Nursing from DePaul University in Chicago, IL, a Post-Masters Specialist Certificate in Nursing Administration and ultimately her PhD in Nursing from Wayne State University as well. She began her teaching career at the DePaul University as a Medical-Surgical nursing instructor and has taught nursing there, as well as Kellogg Community College, Wayne State University, Michigan State University and Eastern Michigan University.

As a practicing nurse, Dr. Marz was a staff nurse for spinal cord injury patients, a head nurse of a Surgical Intensive Care Unit, nurse researcher at St. Joseph Mercy Hospital in Pontiac, Michigan, and served as Assistant Vice President of Nursing for Sparrow Hospital and Health System from 1992 until 2001. After becoming the Director of EMU School of Nursing in 2001, Dr. Marz further distinguished herself as an academic leader within the organization. In 2003 to 2004, Dr. Marz served as the Interim Associate Dean of the College of Health and Human Services and from 2004-2007 served as the Associate Vice-President for Extended Programs. From 2007 to 2011, Dr. Marz was the Coordinator for University Accreditation at EMU and became a Peer Evaluator for the Higher Learning Commission. In July 2012, Dr. Marz served as the Interim Director of the School of Nursing and ultimately returned to teaching in 2013 as a Full Professor. Dr. Marz, as a specialist in nursing administration, has supervised the interdisciplinary Quality Improvement in Healthcare certificate program and has taught both graduate and undergraduate courses in leadership, management, and health care systems.

For Dr. Marz's unwavering commitment to the EMU School of Nursing, its students, and to the profession of nursing, the faculty and I are pleased to endorse Dr. Marz for emeritus faculty status.

This letter is written to express my support of Carole Pawloski's nomination for Emeritus Faculty status. Carole Pawloski has served the Art Department for 27 years, 2 years as a part-time lecturer and 25 years as the department's Visual Resource Librarian. During her tenure at Eastern Michigan University she managed a collection of over 6000 slides, oversaw the transition of slides to digital media, and taught a variety of Art History courses, most notably ARTH 470 Arts of Africa.

Carole's most recent and significant contribution to the Art Department has been transforming the slide library into the Visual Resource Library, a facility dedicated to various digital production tools and equipment as well as facilities for archiving and documenting artwork. This transition included the conversion of the slide library to a digital image archive, assisting all Art Historians with transitioning from slides to digital presentation tools, and assisting the department as a whole with the oversight of its digital projection equipment and maintenance. The digital production equipment and tools housed within the Visual Resource Library include a wide assortment of equipment available for student check-out including digital video cameras, digital still cameras, projectors, and various audio recording equipment. In addition to the equipment available for check out Carole Pawloski oversaw the creation of a facility available to all Art Department students that accommodates both large format printing and vinyl cutting/plotting.

Throughout her years as our Visual Resource Librarian Carole actively participated in visual resource professional organizations. She regularly brought back new methods and approaches for the dissemination of artwork in the classroom. In addition to the transition mentioned above Carole developed and organized a series of short lectures and workshops called Tech Talks. These lectures and workshops, taught by graduate students and EMU faculty and staff, focused on a wide range of topics relating to the role of art in a digital society and professional practices of artists and designers.

As our visual resource librarian Carole Pawloski has made long lasting impact on the art department. Once again I offer my support of the nomination for Emeritus Faculty status.

This letter is to serve as support for Professor Carole Pawloski's nomination for Emeritus status. Professor Pawloski's nomination for Emeritus status was unanimously supported in a vote at the Art Department faculty meeting of March 18, 2016.

Professor Pawloski served in the Art Department as a Visual Resources Librarian for over twenty-five years from 1989 to 2016. Most significantly, during that time she played a key role in helping facilitate the Art Department's transition from reliance on analog to digital technology and instructional resources. She managed the digitalization of the Art Department's substantial slide collection and assisted in overseeing the technology upgrading of classrooms and the adoption of online applications to make visual materials available for instructors and students alike. At the same time she also trained and assisted faculty in how to use and access digital resources and equipment. For that, many faculty members in the Art Department owe her a great debt of gratitude. Furthermore, she always made her best efforts to insure that the technology in classrooms had accessible and smoothly running digital environments. Even the most tech savvy faculty felt it comforting to know that Carole was around to help them get out of the inevitable technical jams and operator errors.

As faculty switched from the use of analog slides to digital formats Professor Pawloski oversaw the successful conversion of the Slide Library into a Media Center and Media Services area that includes equipment checkouts, large format printing services, as well as educational resources. To decommission the slide library she oversaw the scanning of over 6000 slides. Thanks to her encouragement and persistence the Halle Library subscribed to ARTstor and Luna databases that are now widely used by faculty members in the Art Department to support the courses they teach and improve student learning.

In recent years she expanded her role by developing the very successful weekly Tech Talk lecture series as a way to assist faculty, graduate students, and those interested from a larger community make a smooth transition into the technical age and provide awareness of new resources to present, research, and instruct. For these lectures she invited faculty with different areas of expertise to present on a wide range of practical and timely topics that included Photographing of Artworks, Shipping of Artworks, ARTstor, PowerPoint, Luna, The Cloud, Google Docs, Wikis, Virtual vs. Real experience, Art Department Web page use, Job opportunities/online networking, Evaluating online resources, Large Format color print prep, and Copyright among others. To increase access she also began to videotape and post these talks on the Art Department web page.

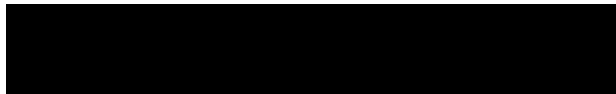
In addition to her role as a Visual Resources Librarian Professor Pawloski taught a variety of courses over the years. These included ART 101 (Introduction to Art), which she often taught in Traverse City, the Art Department's former capstone course (FA 479), and most significantly Arts of Africa (ARTH 470/570). This last course has been an important part of the Art Department's offerings of non-western art. Her first-hand experience of having lived in West Africa and knowledge from graduate study will be difficult to replace in the art history curriculum.

In her over twenty-five year career at EMU Professor Pawloski provided a great amount of service to the Art Department and university. She served on a variety of committees throughout her career in the Art Department including the MFA and MA Committees, Grievance Committee, Instructional Computing Committee, Art History Committee, Department Head Search Committee, among others. Several of these committees, including the Advisory Committee and as Instructional Computing Committee, she chaired at various times. Outside the department she served on the College Arts and Sciences and acted as Library Liaison representative for the Art Department among other roles.

In addition to her service and function as a faculty member and Visual Resource Librarian Professor Pawloski maintained an active scholarly and studio practice. She was actively involved in the Visual Resources Association presenting and publishing. Over the years she has continued to produce and exhibit artworks and even curated an exhibition in the Student Gallery of artworks made out of recycled slides, which was cleverly titled "One Last Slide Show."

For her many years of service, the Art Department enthusiastically recommends Emeritus status for Professor Carole Pawloski.

Melvin T. Peters, Ph.D.: Professional Biography

Dr. Melvin T. Peters is an Associate Professor in the Department of African American Studies at Eastern Michigan, where he taught for twenty-four years from 1992 to 2016. He has taught previously in the English Departments at: Wayne County Community College, Michigan State University (featuring courses in American, African and Native American Literature), and in the public schools of Detroit, MI and Columbus, OH. He holds a B.A. degree in English and Spanish from Marshall University in his home town of Huntington, WV. He holds M.A. and Ph.D. degrees in American Literature (specializing in all genres of African American Literature) from Michigan State University.

At EMU he taught a multidisciplinary spectrum of African American Studies courses. He specializes in the Cultural History and Cultural Continuity of the expanse of the African Diaspora as expressed in literature, music, film, history and their relationship to socio-political movements. His courses included The Poetry of Black Men and Women, The Literature of Black Liberation, a historically wide array of African American and African Diaspora Social Movements courses, Introduction to AAS, Black Music and Social Change, Hip Hop Lyricism in African American Culture, and Films of the African American Experience (African American Literature Adapted to Film).

As the cultural arm of the AAS Department, Dr. Peters wrote the proposals and directed some important contributions to the university community and to the community at large. These were accomplished during Dr. Robert A. Perry's tenure as AAS Department Head. The first of these was Roger Wilkins' stint as McAndless Visiting Scholar in 1998. Mr. Wilkins' distinguished career included being the "first" African American in a number of previously segregated roles: Assistant Attorney General of the USA

during the Lyndon Johnson administration, a Pulitzer Prize winner as a member of the editorial board of THE WASHINGTON POST when Richard Nixon was taken down, signed columnist and member of the editorial board of THE NEW YORK TIMES. He concluded his career as a Professor at George Mason U.

The second was done in conjunction with Dr. Charles H. Wright of the Museum of African American History that bears his name coordinating a day long symposium in honor of the 100th birthday of the legendary Paul Robeson. This event, which featured African drummers and vendors, was held in the old Hoyt Conference Center and attracted hundreds of attendees. Dr. Peters coordinated a morning long panel discussion focusing on the facets of Robeson's career that featured university scholars from MSU, Lansing Community College, and Dr. Michael Forbes (an AAS/EMU graduate who was then pursuing his Ph.D. at UMass in Amherst. He coordinated an afternoon session with EMU and area students and professors doing dramatic readings from the international body of praise poetry dedicated to Robeson, as well as a sacred dance performed by a Chicago dancer to Robeson's spiritual recordings. Dr. Peters made the arrangements with the keynote speaker the late great writer activist Amiri Baraka.

The last of these major cultural events was the proposal brought that the internationally acclaimed poet activist the late Jayne Cortez to EMU as McAndless Scholar in 2002. Dr. Peters team taught a Black Recorded Poetry course with Ms. Cortez, who conducted public appearances that included two extremely well-attended poetry performances – one with the renowned Black British poet Linton Kwesi Johnson, one with her band The Firespitters, still another on the relationship between abstract art and poetry featuring her husband the internationally recognized sculptor Melvin Edwards.

Dr. Peters has a long record of service to student organizations, both as Faculty Advisor (Black Student Union, Native American Student Organization, The Poetry Society, and the NAACP among others) and as

an invited speaker on numerous occasions over the years. In his fifty-year career as a classroom educator, he regularly mentored hundreds of youth including McNair Scholars and At-Risk Students.

At EMU Dr. Peters served on several committees most notably the CAS' College Advisory Council and Arts Committee and on the Faculty Senate. He was an active member of the AAUP; he was once elected to the Union's Executive Committee. He served as the Union Steward for the AAS Department for twenty-four years. In 2015 in Starkville, Mississippi he was presented with an annual mentoring award by the forty-four-year-old National Association for Ethnic Studies. He currently serves on the Advisory Board of the NAES.

Dr. Peters has presented his research and conducted workshops focusing on such topics as: African American Literature and Film, African American and African Caribbean Poetry, African American Social Movements, Hip Hop Lyricism, African Literature, and on major personages (Paul Robeson, Malcolm X, Jayne Cortez, Chester Himes, James Baldwin, The Last Poets, Linton Kwesi Johnson) at universities and scholarly conferences and workshops all across the USA and internationally in: Port-of-Spain, Trinidad-Tobago; Vancouver, British Columbia; Bologna, Italy; Amsterdam, The Netherlands (on three occasions); Melbourne, Australia, and Budapest, Hungary.

On March 18, 2010 he appeared on National Public Radio's "All Things Considered", interviewed by Neda Ullaby about Tyler Perry. On May 1, 2014, he was the subject of a two-hour filmed (filmed in and around Pray-Harrod) interview on "The Significance of Malcolm X to African American History & Culture" for Anatolia Films based in Istanbul, Turkey. On May 19, 2016, he was honored in a large event billed as "Tribute to a Master Teacher" featuring a panel discussion (with five former students from 1967 forward, four of them EMU graduates, two of whom are university professors) and original poetry (Umar Bin Hassan of the legendary Last Poets, and three recent EMU graduates) and a dance (by a 2016

EMU grad). The venue for this two-hour celebration was the General Motors Theater in the Charles H. Museum of African American History in Detroit, MI. Three of the students involved were AAS majors at EMU and mentees of mine: Ms. Dara Walker (currently writing her dissertation at Rutgers U.), Dr. David Goldberg of Wayne State U., and Mr. David Walton (currently writing his dissertation at Michigan State U. and an AAS lecturer).

He has published occasional poetry and scholarly essays on subjects like: The Harlem Renaissance, Hip Hop as a Pedagogical Tool, Slave Rebellion Depiction in African American Literature, and "Curtis Mayfield: The Poet of Soul in a Griot Mold" in Diane D. Turner's (ed.) FEEDING THE SOUL: BLACK MUSIC, BLACK THOUGHT from Third World Press in 2011. He has published several essays in conjunction with the Black Liberation Film Series on the website of The Wright Museum of African American History in Detroit.

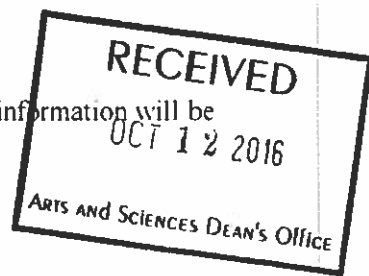

I am writing on behalf of the Journalism Program faculty to nominate our recently retired colleague, Professor James Pinson, for Eastern Michigan University "Professor Emeritus" status. As I'm sure you are aware, Professor Pinson was a respected, tenured Journalism professor in the Department of English Language and Literature, where he served for 25 years.

Dr. Pinson came to Eastern in 1990 after earning a doctorate in journalism from the University of Missouri at Columbia, one of the country's top journalism schools. He also completed his master's degree in creative writing and bachelor's degree in English at Missouri, where he worked with the award-winning *Columbia Missourian* campus/community newspaper for a total of nine years. His other professional experience includes four years as a copy editor for the *Grand Junction (Colo.) Daily Sentinel* and a stint on the copy desk at the *Monroe (Mich.) Evening News*.

Professor Pinson has a strong, national reputation. He is well known for his co-authorship of the widely used textbooks, *Working With Words* and *The Art of Editing*, as well as workbooks that accompany these texts. He continues to work on frequent updates. From 1996 to 2009, Dr. Pinson was a proctor for the Dow-Jones Copy Editing Internship Program and, each spring, a trainer for this highly competitive program at the University of Missouri. Dear Dr. Longworth,

It is my honor to provide my highest recommendation for Emeritus Faculty status for my esteemed colleague, Dr. Valerie Polakow. Since 2000, I have known and deeply respected Dr. Polakow as a faculty colleague in the Department of Teacher Education. Throughout her 28 years at Eastern Michigan University, Dr. Polakow has earned high regards and a reputation as an outstanding educator-scholar, active contributing community member, and academic professional among the EMU, national, and international communities.

Dr. Polakow's professional contributions as an educator-scholar are exceptional in all regards. She has received the highest ratings from her graduate students each and every semester. She served as the co-coordinator and a member of the doctoral coordinating committee of the Educational Studies doctoral program for the past two years. As a doctoral faculty, she chaired three completed dissertation committees and will finish five remaining doctoral committees by her official retirement this August 2016. In addition, she is currently serving on seven other dissertation committees. Dr. Polakow has supported, mentored, and advised countless students. She has also served on the EMU College of Education's Human Subjects Review Committee from 2012-2016. Because of her exceptional skills in supporting EMU graduate students, she was recognized by the EMU community with the 2013 Graduate Faculty Mentor Award.

Dr. Polakow has positioned her prolific scholarship to advocate for and represent the voice of the disenfranchised, marginalized, and most vulnerable populations in our communities. Her contributions in the field of early childhood with a focus on child poverty and welfare as well as issues related to affordable childcare, women's access to postsecondary education, children's rights, and the feminization of poverty serve as exceptional examples of the ways in which educational research can influence policies, programs, and further scholarship in regards to social justice, equity, and educational opportunities. Because of her insightful and dedicated attention to this research literature, she was recognized with the 2015 American Educational Research Association's (AERA) highly prized Critical Perspectives in Early Childhood Education Distinguished Career Award. She has also been awarded numerous other awards that include: the 2014 EMU Alumni Teaching Excellence Award, the 2013, the AERA Distinguished Contributions to Gender Equity Award, the 2002 EMU Ronald W. Collins Distinguished Faculty Award, a


1995 Fulbright scholarship, and the 1994 Kappa Delta Pi "Book of the Year" award for her highly regarded *Lives on the Edge Single Mothers and their Children in the Other America*. Dr. Polakow has held three visiting school appointments and earned numerous internal research awards from the EMU community.

In addition to the two additional book contracts in progress, she has published eight books, 24 book chapters for which she was the lead author for all but three of them, and has 49 published articles or reports. She has been invited to present at eight international conferences and at 18 national, regional, and local forums. Dr. Polakow has presented her work at over 60 international, national, and regional conferences. To conclude that she is a prolific scholar does not quite capture the depth and breadth of her dedication to her scholarship and the influence she has made on the academic community at the international, national, and regional levels.

Dr. Polakow also provided public interviews as an expert on her scholarly work and interests for several broadcast programs by the National Public Radio and also for the weekly Copenhagen, Denmark newspaper. In addition, she was interviewed for a video-documentary, *The Breeding of Impotence* by filmmaker, J. Arthos that later was nominated for an Emmy Award. To name just a few of her professional service activities, she was the U.S. coordinator of the International *Children's Rights/Children's Voices Project*, the co-editor of the online journal *Power Play: A Journal of Educational Justice* as well as served as a reviewer for Teachers College Press, SUNY Press, Rutgers University Press, the *Journal of Urban Education, Anthropology and Education, and Children and Youth Services*. Her wisdom and expertise is sought out and recognized in the public, private, and academic sectors in multiple and often intersecting disciplines.

Dr. Polakow has and is continuing to be an outstanding member of the Eastern Michigan University community. Her ethical, conscientious, and inclusive approach to her work and the ways in which she engages in many relationships to support students, colleagues, and the larger mission of the university is beyond compare. She is truly exceptional in every aspect of her teaching, research and service and is well-deserving of being granted Emeritus Faculty status upon her retirement in August 2016. She will be terribly missed by all who have loved and appreciated her at EMU, but I know for certain her work will continue to inspire, instruct, and motivate others for decades to come!



Wade is probably best known among faculty and students at Eastern Michigan University for two things. First, since his hiring in August of 1991, Wade has worked incredibly hard to build a strong research center with strong ties to industry that focuses on nanotechnology and tribology applications. His work in these fields has led to several important grants from a variety of sources and allowed him to develop a one-of-a-kind facility filled with several high precision instruments used for characterizing the surfaces of different materials in incredible detail. I write to nominate Professor Marjorie Ziefert for emeritus faculty status at Eastern Michigan University. This nomination is based on the recommendation of Dr. Jennifer Kellman Fritz and affirmed by the School of Social Work faculty, as expressed in a unanimous vote (20-0-0) taken on April 15, 2016.

Professor Marjorie Ziefert has devoted her life's work to advancing social justice. She began her career as a social worker in New York City, earning her MSW at Columbia University. She joined the faculty of Eastern Michigan University in 1981 and advanced through the ranks to Full Professor, serving the University for a total of thirty-five years. Through those years, she devoted remarkable and sustained energy and effort to students, to the social work profession and to community service. Throughout her career, Professor Ziefert committed herself to the advancement of the social work program, serving as BSW Director (1996 -1999, 2002-2006) and School Director (2005-2009) as well as a committed and thoughtful colleague. As a teacher and scholar, Professor Ziefert devoted years of effort to advancing services for student parents on our campus, co-authoring (with Polakow and Robinson) a remarkable and important study on this subject in 2014. Professor Ziefert also presented frequently within the profession on how to protect the rights and advance the future of students with criminal histories. The contributions Professor Ziefert made-- and continues to make--reflect her enduring commitment to student success.

Throughout her career, Professor Ziefert has also had strong and enduring commitments to the well-being of families and children in the community. She played a leadership role on a range of large and important grant projects related to strengthening child welfare service delivery. One of these centered on providing services to young people emerging into adulthood from childhood experiences in the foster care system. Her scholarship across the years has had a strong focus on linking research and practice in ways that make a difference for children and families. She has also led in the profession, serving the National Association of Social Workers organization in Michigan in a variety of roles, including President (2010-2012). In recent years, Professor Ziefert's service to the profession has included developing and leading study tours for social workers in Cuba, and this strong professional interest is reflected in her recent scholarship. In 2014, Professor Ziefert's history of service to the profession was honored with the NASW Michigan Lifetime Achievement Award.

In recognition of this rich legacy of service to the University community and the social work profession, I am delighted to nominate Professor Marjorie Ziefert for Emeritus status at Eastern Michigan University.
