Letter in support of Laura F. Davis, MSW, PhD, application for Emeritus Status

Dr. Davis has been a member of the EMU faculty since 1994 when she joined the faculty from Michigan State University. Her appointment to the faculty came two years after the program was accredited by the Council on Social Work Education for the first time, and she was instrumental in supporting the steady growth and enhancement of the MSW program.

Over the twenty-five years she was a member of the faculty at EMU, Dr. Davis contributed to the School, College and wider University in multiple ways. Dr. Davis developed courses, mentored and supported students in both the BSW and MSW programs, supported faculty, and helped develop the Continuing Education program that supported the MSW licensure needs for social workers in Southeastern Michigan.

Dr. Davis developed courses in administration and supervision that form the basis for students interested in courses in this area. She mentored students interested in these areas and also taught the Field courses in both the BSW and MSW program, committed to supporting students in the field in order to make sure they achieved the competencies required by CSWE.

Dr. Davis also served as a union steward, helping to rewrite the DED and DID, successfully advocating that the MSW program be seen as a year-round program. This recognition is a necessity for students to receive the level of financial aid needed for them to successfully enroll in courses year-round. She served as a guide for new faculty as they sought to understand the requirements of their job and move on to successfully apply for tenure and promotion.

Dr. Davis also helped to bring the Continuing Education program operating out of EMU and staffed by a mix of community social workers and EMU social work faculty. She helped establish EMU in the NASW cooperative, which allowed EMU courses to be listed across Michigan. She helped set up the year-old partnership with EMU that allows the School of Social Work to have more control over the kinds of courses that were offered as well as giving faculty more opportunity to be involved in developing and delivering CE courses.

I believe that Dr. Davis' commitment to the students and faculty within the School of Social Work and across the university, makes her appointment as Emeritus Faculty an obvious choice. Her twenty-five years of service to the School and the University, but most especially to the students, is the kind of service that supports Emeritus Status.

Re: Dr. Jamin Eisenbach, Professor of Biology – Emeritus Status

On August 31, 2019, Dr. Jamin Eisenbach retired from EMU after 32 years of distinguished teaching, scholarship, and service to the university. Dr. Eisenbach had been hired to replace a legend – Dr. Bill Fennell – in teaching BIO 105, Biology for non-majors. He quickly made that course his own, and began establishing his own legend. A masterful lecturer, Dr. Eisenbach gave performances in every class that enthralled students and taught them to love biology. No matter the topic at hand, he always had a fascinating story drawn from his beloved world of insects that perfectly demonstrated the concept being discussed. Dr. Eisenbach was singlehandedly responsible for recruiting scores of students to become biology majors as a result of their experience in BIO 105.

When the Biology Department revised its curriculum in 2001, it was decided that we needed the best faculty to teach the introductory courses for majors, to capture the imagination of the students and make sure we gave them the best possible introduction to the world of biology. It was no surprise that Dr. Eisenbach was the first faculty member tapped for this opportunity. He spent the next 18 years inspiring and entertaining incoming biology majors, and it was no coincidence that the number of majors grew substantially during that period.

Dr. Eisenbach was a consummate educator who always bent over backwards for his students. His lectures were performance art. He spent hours on each class, carefully crafting and organizing the material to explain complex concepts carefully and build new concepts on top of existing ones. The presentation was where the performance came in. Dr. Eisenbach had a high-energy delivery that entertained students while they were educated, and some of his jokes were legendary. As times changed, Dr. Eisenbach worked new pedagogies into his classes, incorporating active learning exercises into his lectures to keep students engaged. He gave as much of himself outside of class as he did inside the classroom, spending immeasurable time helping students to not only master the course material but also to develop study habits that doubtless served them well in all of their classes. Dr. Eisenbach's teaching proficiency did not go unnoticed; he was a deserving recipient of the 2001 EMU Alumni Teaching Excellence Award and the 2002 Ron Collins Distinguished Faculty Award for Teaching II.

Dr. Eisenbach was a superb colleague as well. He was eager to share his knowledge of the profession and how the university worked, and as a result he became an unofficial mentor to nearly every new faculty member in the department. He had a knack for getting to the heart of any issue under discussion at faculty meetings, often pointing out a perspective that had not been considered by anyone else. He served the department with distinction on numerous department standing committees, as a member of the General Education Course Vetting Committee, and as a long-serving representative to the Faculty Senate.

Dr. Eisenbach was one of, if not the best, instructors in the history of the EMU Biology Department, and he gave of himself to students and faculty alike. In many ways, he was the face of the Biology Department for over three decades. Therefore, the Biology Department requests Emeritus Faculty status for Dr. Jamin Eisenbach, in recognition of his many contributions to EMU.

Dear Social Work Faculty.

I am writing this letter of recommendation for Dr. Sylvia Sims Gray, Professor in the College of Health and Human Services, School of Social work. Dr. Sims Gray has established a commitment to high quality teaching, collaborative learning and outstanding mentorship. She has been a source of support, guidance and inspiration to me and other members of the faculty in the School of Social Work during her years as a faculty member.

Dr. Sims Gray has been my mentor and friend the past 14 years that I have been teaching at EMU. She was instrumental in affecting change in our undergraduate curriculum and policies through her work on the BSW Committee where she assisted, not only myself, but all of the committee members in understanding past challenges in the program and our need to work collaboratively to establish goals for the program and an action plan to achieve them.

Through her efforts, Social Work students in the NABSW completed numerous community service activities in the University and larger community while gaining valuable leadership and community organizational skills. When I became the faculty advisor for the NABSW Dr. Sims Gray provided

exceptional support and many hours of her personal time to ensure a smooth transition and provide continued advice and support.

She is a generous, thoughtful, and courageous individual who has a passion for social justice and fairness. She has high ethical standards for herself and for others and believes in solution focused efforts to address problems and issues, large and small. She has been an inspiration to me and others during my years at EMU and she is highly respected by faculty, staff and students. She is truly deserving of Emeritus Status.
