It is my sincere honor and privilege to recommend Dr. James Berry for Emeritus status at Eastern Michigan University. Dr. Berry was recruited to join the professoriate at EMU in 1991. Throughout his tenure, he has demonstrated excellence in his teaching, service, and scholarly commitment to our students, the field of Educational Leadership, and Eastern Michigan University.

Upon arriving, Dr. Berry played a significant role in the establishment of the first doctoral program at EMU, the Doctorate in Educational Leadership. He spearhead the efforts to have the doctoral program accredited through the North Central Associations of Colleges and Schools (NCA). He then went on to facilitate the establishment of the cooperative doctoral program with Grand Valley State University. During his tenure, he has worked to enhance the quality of dissertations and the dissertation process. Dear Dean Heller, Provost Longworth, and Regents of Eastern Michigan University,

It is our pleasure to recommend Dr. Michael Bradley for emeritus status. Dr. Bradley retired at the end of the Fall 2021 semester, after being a faculty member in our department for 26 years. During this time, he was a highly valued University and departmental colleague who distinguishing himself in teaching, research, and service.

While at EMU Dr. Michael Bradley (Mike) taught courses ranging from introductory, general education classes for non-science majors to upper-level classes for geology majors. He was an effective and enthusiastic instructor and had an unusual ability to communicate ideas and information. His classes were rigorous, innovative and, according to students' evaluations, enjoyable. He was able to simplify difficult concepts, and empowered students in the learning process by using a combination of theory, methods, and practical applications. Indeed, his students greatly appreciated his teaching style, often commenting on how engaging and interesting his lectures were, and how at the end of the semester they had a proud feeling of accomplishment. For a number of years in the 1990s, he taught the ESSC 356 field course for the Geology program in Colorado, which was a major undertaking.


Outside the classroom Mike was a knowledgeable mentor to the students. He supervised several independent projects and Honors theses, spent innumerable hours helping students both during and outside office hours, as well as working one-on-one with geology majors on research projects. Mike's door was always open, and he was happy to share his knowledge and experience with his colleagues offering advice, support, and encouragement. He maintained high standards for himself both as a teacher and as a member of the EMU faculty, had a great sense of humor, and a positive attitude that made working with him a pleasure.

Mike considered research a fundamental component of his work at EMU. When he joined the faculty, his research was largely field oriented and centered around the Laramide geologic structural history of the Uinta Mountains, Utah and the Sevier overthrust belt of Utah and Wyoming. He published geologic maps of two quadrangles, a major undertaking that requires specific skills and substantial physical stamina to accomplish. Through time his interests shifted toward K-12 and undergraduate college education. He worked with the then G&G education specialists writing three grant proposals, wrote the lab manual for the ESSC 109 class, and developed an online version of the Petroleum Geology class (ESSC 430) that included original material largely based upon his research and years of experience in the petroleum industry, so a large component of the class contained original research.

Beyond teaching and research, Mike played an instrumental role in departmental affairs, and did so in a wide variety of ways. He served multiple terms on the departmental Personnel and Finance Committee and Instruction Committee, often chairing them. Since 1995 he chaired all but one of the search committees for new faculty positions in the Earth System Science (ESSC) program. He served as the ESSC Lab Coordinator for nine academic years, during which time he trained and supervised graduate students teaching labs, designed new labs, and updated existing ones on a regular basis. For many years he was the department class scheduler and the G&G representative on the College of Arts and Sciences College Advisory Council.

In summary, it is a pleasure to nominate Dr. Bradley for emeritus faculty status. He is most deserving of this honor for all that he has given to the department and the broader EMU community.

It is a pleasure and my honor to provide my enthusiastic recommendation to award Emeritus Faculty status to Dr. Paul Howard, Professor in the Department of Mathematics and Statistics.

Paul's career at EMU spanned 52 years. He is a very impressive individual with a long state of contributions and accomplishments.

Paul earned the Bachelor's degree in Mathematics at the University of Missouri and the Ph.D. in Mathematics at the University of Michigan, specializing in mathematical logic. He completed the Ph.D. program in 1970 and began working at EMU in the Math Department. Paul tells this funny history about being hired at EMU in 1970: "There was no job interview. After applying, one Sunday night I got a call from the chairman asking me if I wanted the job. I said 'Can I have a few days to think it over?' and he said 'No.' That was the start of my 50+ years at EMU."

Paul is a prolific researcher and writer with an international reputation. His published work in mathematical logic is highly regarded and he is considered an expert in the forms of the axiom of choice. Paul's book, Consequences of the Axiom of Choice, published by the American Mathematical Society, is described as "a breathtaking catalogue of choice axioms" and "produced with impeccable scholarship." Paul was awarded the Distinguished Faculty Award for Research and Publication earlier in his 52-year career (in 1987). He is a very active and accomplished scholar and research mentor, then and now. He has published approximately 70 research articles and books, as recently as March 2021 and with at least 15 publications in the last decade. Paul states that his career highlights, both early career and late career, are mathematical collaborations with great colleagues and working with students on research projects. That Paul has been generous in his time and commitment to student researchers is an understatement.

A quote from a previous department head, Dr. Bette Warren: "Paul Howard is one of the rare faculty members who truly excelled in all areas: scholarship, teaching and service. He was an inspiring, effective and beloved teacher at all levels, generous with his time and encouragement. Whether serving on the major committees or volunteering for special duties such as organizing retirement events, Paul's service to the department was exemplary. Paul is a talented, generous and throughly decent man who will be sorely missed." I concur 100%.

In preparing for Paul Howard's 50-Year Service Recognition, friends and colleagues used these phrases to describe him: kind-hearted, friendly, humble, funny, encouraging, always makes me smile, and we are so lucky to have him as a colleague. Paul's friends and colleagues also desribe him as being famous for being a bicycle commuter for 50 years, expressing multiple stories about Paul biking to EMU, even in the middle of winter through the snow.


