I am pleased and honored to recommend the conferral of Emeritus status on Ms. Michelle Henry, whose retirement will become effective at the end of this week. Of her 40 years working in higher education, the last 20 have been at Eastern Michigan University. Her first position at Eastern was Coordinator for Distance Education Programs in the Office of Continuing Education. In December 2005, Michelle joined the EMU College of Business as Coordinator for Graduate Programs. Following a stint as Interim Director of Academic Services, she was appointed Director of Graduate Business Programs in 2013. She is also a proud Eagle alumna, having earned a Master of Arts degree in Higher Education/Student Affairs.

I enjoy a rare vantage point for appreciating the magnitude and quality of Michelle's service as our Director of Graduate Programs, having filled the same role for another institution earlier in my career and having worked closely with other individuals in that function at four different universities. I have been deeply impressed with Michelle's rich combination of absolute empathetic care for and nurture of our diverse student population, her marketing prowess in a resource-constrained environment, her functional efficiency, her collegiality that never wavers even in the most challenging circumstances, and her almost superhuman work ethic. Her tireless work with faculty to sustain and build the quality of our graduate programs and to enhance their visibility has been a vital contributor to the explosion of rankings that has come about in recent years. As one who enjoyed the support of three full-time staff members when I served in a comparable capacity at another university (recruiter, advisor, and secretary), I am in awe at what Michelle has achieved flying solo in her office for the last few years.

I enjoy the opportunity of hearing the good and the bad about COB faculty and staff. The enormous impact of Michelle's work is perhaps best seen in the heartfelt recognition of those she has served. Her students universally express affection and appreciation for her very personal attention. Just yesterday, I was present when a student dropped by to thank Michelle for helping her find a place and success at Eastern, the school that is right for her. At the conclusion of an AACSB peer-review-team visit to a university in Saudi Arabia this year, I had the opportunity of dining with three alumni who have risen to prominent positions in government and industry in that country. They shared happy memories of their time at Eastern and spoke with deep respect and appreciation of the life-altering impact of some faculty and staff members. Mentioned prominently in that conversation was Michelle Henry. Her colleagues recently named her the 2023 recipient of the College of Business Outstanding Staff Award. The outpouring of respect, appreciation, and love from many present and former colleagues and students at her recent retirement event was prolific and heartwarming.

The privilege of working closely with Michelle has been among the highlights of my five years at Eastern. To me, she is a tangible manifestation of our very best qualities. I am humbled and grateful to be able to recommend her for Emeritus recognition.

Michelle joined the College of Business a few years after I started teaching the MBA capstone course. As I was interested in our MBA program, I was fortunate to work with her for a very long time. In addition, I worked with Michelle as a member of the MBA curriculum committee (CIMBAC) for a few years and then as the chair of CIMBAC for almost ten years.

As the chairperson of the CIMBAC, I not only worked with her, I observed her recruiting graduate students, advising them to take appropriate courses and helping them graduate in a timely manner. Her work at the graduate office went well beyond recruiting and advising students. She worked tirelessly with faculty as an effective support for the continuous improvements of all our graduate programs. I personally feel that as the Director of Graduate Programs Michell was a pillar of strength in supporting our graduate programs. It'll be hard to find someone to fill her shoes. She will be missed not only for her deep commitment to the welfare of our graduate programs, but also for her style of work, one that valued collegiality and civility. Appropriately, she was the recipient of the 2023 College of Business Outstanding Staff Award.
