According to the resolutions which establish these public school academies (charter schools), vacancies on the Boards of Directors shall be filled by the Eastern Michigan University Board of Regents.

Detroit Public Safety Academy

Charles Simms is the Fire Commissioner for the City of Detroit. He earned a Master of Education in Educational Psychology and Bachelor of Arts in Psychology with a minor in Business Administration from Wayne State University. This is a re-appointment.

Dr. Joseph F. Pollack Academic Center for Excellence

Tina Poole is a Grant Contract Officer IV for Wayne State University. She has a Master of Education in Education Leadership and Policy Studies as well as a Bachelor of Arts in Communication from Wayne State University. This is a re-appointment.

Regina Walker is a Financial Professional for The Prudential Company of America. She earned a Master of Science in Management from Walsh College and a Bachelor of Business Administration from Eastern Michigan University. This is a re-appointment.

Presentation: GameAbove College of Engineering and Technology (Section 10)

Dr. Mohamad Qatu, Dean, GameAbove College of Engineering and Technology, presented an update on the top 5 college priorities:

- Build a competitive infrastructure (including Sill and Roosevelt renovation).
- Advance the quality of academic programs (external accreditation).
- Support domestic and international student recruitment.
- Improve the financial health of the college (including fundraising).
- Advance research and engagement of faculty and college.

Emeritus Faculty Recommendations (Section 7)

Dr. Rhonda Longworth, Provost and Executive Vice President, recommended that the Board of Regents grant Emeritus Status to two (2) former faculty members.

Faculty:

Elisabeth Daumer, Professor, Department of English Language and Literature from 1992 to 2023 who retired after 31 years; and D. Robert Okopny, Professor, Department of Accounting, Finance, and Information Systems from 1988 to 2022 who retired after 34 years.

STAFF SUMMARY

The Collective Bargaining Agreement between Eastern Michigan University and the Eastern Michigan University Chapter of the American Association of University Professors (AAUP) provides that a faculty member who has served the University for at least fifteen (15) years may be nominated for Emeritus Faculty Status upon retirement.

The nominations for these individuals have received the support of the Department Head or School Director, the Dean of the College, and the Provost and Executive Vice President for Academic and Student Affairs.



- Despite reductions, CAS (in the past three years):
 - Updated nearly all computer labs (along with department/school student fees and IT)
 - Purchased new instruments for the band/orchestras
 - Bought improved classroom furniture (including ADA and drawing tables) in a few rooms
 - Created an active learning classroom (with plans for more)
 - Started construction on a new Arts building (primarily donated funds)
 - Obtained a new Nuclear Magnetic Resonance (NMR) in Chemistry (funded primarily by the Provost's Office)
 - Purchased fire retardant curtains for the theatre and headsets for theatre productions
 - Installed new carpeting in Fish Lake dorms
 - Bought equipment for closed captioning of live events
