- 1. November meeting minutes approved 13-0-0
- 2. Sherry Owens and Kristen Olson-Roque introduced themselves as new members. Wes Howell introduced himself as this was his first meeting.
- 3. Chair report :
  - nominations for commission chair next year, please send an email to Tom Kovacs by April 12.
  - Bike share program with SPIN was to begin in September, but the deal fell through in July, were interested in scooters. However scooters are not allowed on campus.
  - <u>Veoride</u> proposed a new deal that is tabled until the Summer. Dockless, unlocked via app. Geo fenced. No up-front cost. What happens if bikes



end up in places that are not easy to retreive? Answer: If it ends up outside of the geofence there is a fee (currently \$120) to the student. If the bike is lost there is a \$500-600 replacement fee. App shows where the bikes are located. Would there be a pop-up that may also notify user of safety concerns? Answer: This is negotiable.

- Ann Arbor bike share, may expand all the way to EMU with two on campus dock sites proposed. Veoride is dockless and charges by the company swapping batteries. Spin bikes would charge using solar panels.
- SPIN: historical conversation and creation of MOU would need to occur again with any vendor.
- We need to account for the use of the sharing of bikes with respect to campus document for student behaviour, and added to the student conduct code. ie: if a fraternity decided to see how many they can collect. Set up an expectation with DPS in advance.
- Athletics was super interested in this. Also provides connection between the COB and main campus. Parking in the green lot and convo center and then biking in on the border to border trail.
- We may want to look at a seasonal limitation. ie: During ice storms? We will need to check in with legal about the liability.
- Is there a cost for students? Each time check out, Veo also includes mileage, SPIN charges for time. Veoride cost is negotiable with 0.50 cents for 15 minutes and \$10 per month typical for university faculty, staff, and students.

- Commission participation: most of the work is done in the subcommittees.
   Everyone in this room is also very busy. Some members have been having trouble with email, what are some communications ideas:
- Strategically, clearly identify with the group, and then assign a caretaker of that goal. They will then make sure that goal is maintained. Break it down into quadrants and then adjust to the goals that suit the person



- Currently the Chairs are : Academic, Operations, planning and admin. Engagement and Planning.
- 10-15 criteria per subcommittee in the STARS. Academic only has two representatives and should have one from faculty senate and one from the provost's office that is still unfilled.
- Engagement subcommittee needs to designate a chair with the loss of the current chair from the commission.
- Operations are working well on their goals.
- Students are doing well with reporting on the STARS
- Cold calling busy people, if they don't recognize the sender, perhaps designate a liaison from over the University who can craft a canned response, and serve as a conduit. - Long term goals: STARS rating system is the bar we need to strive towards, marketing, recommendations are also key to planning. Address the areas where we are deficient, perhaps a full-time person, we are currently in the analysis, measuring phase of STARS

- Marketing: Sherry Owens has 8 questions :

#### SC-OP-1-2019

WHEREAS the Sustainability Commission has been tasked to assess, improve, and communicate Eastern Michigan University's (EMU's) level of sustainability as defined by our working definition of sustainability found on our website; and

WHEREAS the improvement of sustainability can be best achieved by a motivated community aware of the importance and benefits of a sustainable EMU; and

WHEREAS the consideration of new EMU employees that have an appropriate level of sustainability knowledge relevant to their position costs nothing, but benefits the university and wider community in creating a culture of sustainability and its focus on environmental vitality, economic development, and community prosperity and resilience;

THEREFORE BE IT RESOLVED that the Sustainability Commission recommends to the president's office that the replacement for the manager; Technical/Mechanical Trades and Utilities would preferably have a background that includes the following:

### • Experience:

- Three to five years experiences implementing sustainable initiatives to improve clean and renewable energy; greenhouse gas emissions; and/or outdoor air quality.
- Involvement in at least one LEED certified project
- Data collection and reporting for Association for the Advancement of Sustainability in Higher Education (AASHE) Sustainability Tracking Assessment and Rating System (STARS) score.



- Desired Qualifications:
  - o LEED Credential:
    - LEED Green Associate
    - LEED AP Operations and Maintenance

#### SC-OP-2-2019

WHEREAS the Sustainability Commission has been tasked to assess, improve, and communicate Eastern Michigan University's (EMU's) level of sustainability as defined by our working definition of sustainability found on our website; and WHEREAS the improvement of sustainability can be best achieved by establishing standards, expectations, and contract obligations for future outside companies servicing, providing management oversight, and completing construction on EMU premises;

THEREFORE BE IT RESOLVED that the Sustainability Commission recommends to the president's office that all future contracts built with outside companies are passed by the Sustainability Commission to make sure sustainability initiatives and requirements are built into these contracts to increase sustainability efforts at EMU and improve this university's Association for the Advancement of Sustainability in Higher Education (AASHE) Sustainability Tracking Assessment and Rating System (STARS) score.

EXAMPLE: If EMU Housing and Residence Life is privatized or invested in for construction purposes, this proposal would entail that the Request for Proposal and final contract(s) made to comply with AASHE STARS credits three through five.

#### Discussion:

Subjective vs. objective guidelines to be added to contracts. Housing residence life has been looked at, and adding that we are a recommending body rather than an approving body. Mike V.: Provide guidance on the front-end. There needs to be consideration for sustainability. Not realistic for the commission to review every contract. "Here are our concerns and considerations" What we could call for in the proposals, please provide this information regarding LEED certification to drive bids and proposals. Which can be a part of the package, could be in the procurement bid pack, and input around sustainable practices, we just closed a bid for merchant services for credit card, but aligning other bids with green initiatives, We are not all experts, so having an expert is desirable. Certain RFPs go out and some Universities, and then the RFP should state that we have a goal of 20% local, proposals and organizations. Consider how each university is at a certain point in their evolution, LEED silver attainment is possible, but



aren't always realistic from a pedagogical standpoint. **Motion to table this discussion** until the next meeting seconded
